Executive Summary

Panama City Port Authority East Terminal Phase Two Expansion

The Panama City Port Authority 's mission is to expand regional economic opportunities by providing modern port facilities, promoting trade, and supporting industrial development. Located on Northwest Florida's Gulf Coast, the Port handles a diverse mix of containerized, breakbulk, and bulk cargoes and supports on-port heavy manufacturing tenants.

Triumph Gulf Coast awarded the Port Authority a \$10 million grant in 2018, a key component of the \$66 million Phase One Development of the East Terminal. This transformational project included the construction of a 260,000 square-foot forest products warehouse, 900-foot bulkhead, and deepening the channel to 36 feet to accommodate deep-draft vessels servicing the new terminal. Commencing operations in February of 2020, new cargo activity at the East Terminal has directly generated port-related job growth and opened new global trade lanes for shippers utilizing the Port. An economic impact study conducted in 2023 by Martin and Associates for the East Terminal determined that these strategic investments and new cargo activity generated 134 direct jobs, and 188 indirect and induced jobs.

Amount of funds requested:

The Panama City Port Authority is seeking \$15 million in Triumph Gulf Coast funding to assist in the Phase Two construction of the East Terminal. Phase Two includes constructing a new 200,000 square foot on-dock warehouse, 600-foot berth extension, expansion of the turning basin, and terminal rail and roadway improvements. This project enables the Port Authority to develop the East Terminal as a modern and resilient breakbulk and forest products facility. The Port Authority will also be able to realize operating efficiencies by consolidating all forest products operations at the East Terminal. This will enable the Port to expand container terminal capacity and long-term, on-port tenant growth at its West Terminal.

Amount and identity of sources for additional funding:

The \$60 million Phase Two expansion of the East Terminal is the second largest capital investment project in the history of the Port Authority. As shown in the table below, the Florida Department of Transportation (FDOT) and The Florida Seaport Transportation and Economic Development Council (FSTED) have committed \$28 million in matching funds to the project. In addition, the Port Authority was awarded an \$11.25 million Port Infrastructure Development Program (PIDP) grant by the U.S. Department of Transportation Maritime Administration (MARAD). The Port Authority has committed \$5.75 million from cash reserves for matching funds for this project.

Location of the Project:

Port Panama City's East Terminal is located on sixty-eight acres of land at the southernmost extent of East Avenue in Panama City. The surrounding communities include Panama City, Millville, Parker, Callaway, and Springfield. The Port is connected by highway and rail, which are both designated as Strategic Intermodal System corridors by the FDOT.

Summary of programs to promote economic recovery, diversification, and enhancement of disadvantaged communities:

The Phase Two Development allows Port Panama City to continue capacity expansion projects, as identified in the Port's 2019 Strategic Development Plan and upcoming 2024 Strategic Master Plan. Long term cargo growth opportunities are dependent on the expansion of the East Terminal. This project potentially provides Historically Disadvantaged Communities



Poverty access to good-paying port and industry-related jobs, and growth opportunities for the Port's service providers.

The support from Triumph Gulf Coast will be invaluable, as it allows the Port Authority to complete the Phase Two Expansion Project and support continued cargo and economic growth throughout our community, and Northwest Florida for generations to come.

Timeline:

The Port Authority is currently undergoing the design, engineering, and permitting for the 200,000 square foot warehouse, 600 Linear Foot berth extension, and turning basin expansion. If the Port Authority is able to enter into a \$15 million grant agreement with Triumph Gulf Coast, the Phase Two Expansion construction on the second warehouse would begin in the third quarter of 2025, with a scheduled completion date in the fourth quarter of 2027. Further, the Port Authority would anticipate completing the permitting process for the berth extension and turning basin in the third quarter of 2027 and construction starting in the fourth quarter of 2027.
